

Report following the July meeting of the Faculty of Pain Medicine Board

The Faculty of Pain Medicine Board met on July 25, 2016 and welcomed the ANZCA President, Professor David A Scott and the ANZCA CEO, Mr John Illott, to the meeting.

The board also welcomed Professor Bruce Robinson, Chair of the Medicare Benefits Schedule (MBS) Review Taskforce and Chair of the National Health and Medical Research Council (NHMRC). Professor Robinson addressed key areas of health care reform.

Professor David A Scott, FANZCA, FFPMANZCA, has been appointed clinical professor with the Melbourne Medical School, University of Melbourne. Professor Scott has been promoted from associate professor in recognition of his leadership and fostering of excellence in research, teaching and policy development in anaesthesia and pain medicine. The appointment also reflects Professor Scott's national and international reputation, and his innovative and distinguished contributions to research and scholarship.

Enhancing efficiency and communication within the Faculty's structure: The board discussed potential committee realignment and the proposal to form an FPM Professional Affairs Executive Committee that would support professional standards, scientific meetings and research and innovation committees. In realigning committee structures there is an opportunity to engage a greater number of the fellowship, and particularly younger Fellows, in the work of the Faculty.

ANZCA Professional Document PS62: Statement on Cultural Competence: The board approved the newly developed ANZCA professional document [PS62 Statement on Cultural Competence](#) and accompanying background paper for publication on the FPM website for a 12-month pilot period.

Election to FPM fellowship: Dr Andrew Jeffreys, FANZCA, FFPMANZCA (Vic) was admitted to fellowship of the Faculty of Pain Medicine by election.

Revision to By-law 3: The FPM Board approved a minor change to by-law 3, [Admission to fellowship of the Faculty](#). An additional clause has been added requiring applicants for admission to fellowship by election to either show how they have already contributed to FPM or how they will contribute in the future.

Training unit accreditation: The Royal Prince Alfred Hospital, NSW and Austin Health, Victoria have been reaccredited for pain medicine training for five and three years respectively. The number of accredited pain units now stands at 33.

The board approved the withdrawal of accreditation for training in the core training stage from the Royal Children's Hospital, Melbourne.

New by-law and handbook for the accreditation of training units: The FPM Board approved [by-law 19, Accreditation of units offering training in pain medicine](#) and the [FPM accreditation handbook](#). Units can apply for an extension before they need to comply with the minimum staffing requirements set out in the by-law. These policies replace *PM02, Guidelines for Units Offering Training in Multidisciplinary Pain Medicine* which was retired. The policies were revised following a review and consultation process to bring the policy for the accreditation of training units in alignment with the 2015 training program.

Build the curriculum and knowledge

Education

2016 examination: Trainees may sit the fellowship examination in either the core training or practice development stage following completion of one long case assessment and two in-training assessments.

The written exam will be held across FPM regional and national offices on Friday November 4. The clinical exam will be held at the Australian Medical Council's National Test Centre in Melbourne on Saturday November 26. The closing date for registrations (written and clinical) is Friday September 30. To register, please complete the [application form](#).

Structured oral viva voce (SOV) and observed structured clinical examination (OSCE) [guidelines](#) have been developed to assist trainees in their preparations.

Learning and Development Committee: The ongoing support and evaluation of the training program continues to be carried out by the Learning and Development Committee.

The SOT Workshop was held in Auckland on May 3 in conjunction with the ANZCA Annual Scientific Meeting and chaired by Dr Meredith Craigie. The workshop focused on practice development stage (PDS) requirements and supervision, workplace-based assessment, forms and processes. SOTs were well engaged in the discussions which were ably facilitated by Maurice Hennessy, ANZCA's Learning and Development Facilitator. Continuing support for supervisors of training with contributions from Learning and Development Committee members is planned for the next half-day SOT Workshop at the Spring Meeting on September 16.

A successful Advanced Clinical Skills Course, convened by Dr Paul Wrigley, was held in Sydney on July 16 and 17 and was attended by 20 trainees. The Faculty would like to thank those who presented, including board member, Dr Newman Harris and FPM Director of Professional Affairs, Professor Milton Cohen. Other facilitators included Professor Mike Butler and Dr Damien Finniss.

Implementation of the FPM Curriculum Evaluation Strategy 2015-17 remains ongoing with support from the ANZCA Education unit.

Revisions to by-law 4 and the training handbook: The FPM Board approved minor updates to [by-law 4](#), [FPM Training Program](#) and the [training handbook](#). The policies were amended to reflect the recent committee restructure and introduction of the accreditation by-law and handbook.

FPM Better Pain Management education program: Progress with this initiative continues. Modules 7-12 are now complete and are now being loaded in Networks. Several organisations have recently made contact expressing interest from their membership in accessing the modules.

Opioid equi-analgesic dose calculator: The FPM Opioid Calculator smart phone app is available for downloading in both Apple and Android formats. There are now more than 10,100 unique users and more than 61,000 sessions. Development of a website to house the app is close to completion.

Medical Board of Australia registration standards: In February, the Medical Board of Australia announced changes to the mandatory Continuing Professional Development and Recency of Practice Registration Standards. They will come into effect from October 1, 2016. All medical practitioners must meet the minimum registration standards, including trainees in specialist training programs. The new standards can be viewed on the [MBA website](#).

Development of FPM position statement or policy around recency of practice: The board approved the development of a position statement or policy around recency of practice and the return to practice of a specialist pain medicine physician who has been absent for at least 12 months.

Graduate Outcomes Survey: The Graduate Outcomes Survey, circulated on June 6 to all new Fellows within three years of fellowship has just been completed and the response rate has been excellent. The FPM survey included FPPMANZCAs and those with dual fellowship. Most respondents completed the section on bullying, discrimination and sexual harassment. The results will be collated and inform our strategies in a number of areas.

Research

Electronic Persistent Pain Outcomes Collaboration (ePPOC): Progress continues with this initiative. There are 58 services which are either collecting data or in the process of implementing ePPOC. NSW Health has committed to fund ePPOC for another three years. Lobbying for a joint Commonwealth/state funding proposal is ongoing.

Pain Device Implant Registry: A briefing was held with the Department of Health, Canberra to discuss proposed governance arrangements, and to seek the additional funding needed to progress this initiative.

Build advocacy and access

Professional

National Prescribing Service – Choosing Wisely Survey: The Faculty has been keen to participate in this initiative of the National Prescribing Service designed to improve patient care. In concert with ANZCA, an FPM working group developed a short list of pain medicine-related practices which may have limited or no benefit to patients, or that may be potentially harmful and these were circulated in a survey to Fellows on June 30 to gauge the Fellows views on items for inclusion. The response rates have been good.

Painaustralia funding: FPM and ANZCA continue to provide support to Painaustralia both financially and through representation on the Clinical Advisory Group.


